Pilgrim and Capital Basset Hound clubs held a 3 day dual field trial at the Niagara River Beagle Club in Batavia, NY on Oct. 19 to Oct. 21, 2018.

Trialers from all over the Northeast came in for this annual event. The weather gods put on a full program from sunny skies on Friday to thunder, lightning, and sleet (or was it hail(?) to a downpour on Saturday with a grand finale of wind and cold on Sunday.

Fireball of Fireside, owned by Ellen Ripper, put together a nice run her first day and was called back High Hound in the second series, first brace. She defended her position well on the second run. A third series was called before the results were announced back at the clubhouse.

It was a special moment when they called her name for first place for this young girl who is only two years old. Her owner received the cherished green ribbon and a lovely Capital District trivet along with 16 points toward the field championship.

Later in the month, in Flemington, NJ, the Berkshire BHC held their Fall field trial at the Central Jersey Beagle Club.

Fireball's experienced and mature brace mate ran in the fourth brace out of ten. The heavy rain the day before made for rabbits that were sitting tight. The gallery held together and worked hard beating the brush to get the rabbits moving.

In the second series, Fireball came back as High Hound. She put on a great run, working several checks to perfection. A third series was called for her challengers. She held her own and earned another first place and 19 points.

Watching bassets use their natural scenting ability to run a rabbit with no help or direction from a human is a thing of beauty.

Driving Directions

From Washington (North):

Take I-66 to US 29 South (Charlottesville). In Culpepper, take US 15 South to Rt. 20 South (Charlottesville/Barboursville). Stay on Rt. 20 (you will do a jog on US RT 33

in Barboursville - a left turn, under the railroad bridge and then right continuing onto Rt. 20).

At Stony Point, go past the Stony Point Elementary School on the left then make a sharp 90 degree turn left (still on Rt. 20). Turn left onto Woodcreek Dr. (about 2 miles)the fifth house on the right (Yellow).

<u>From Washington (South):</u> Take I-95 South to Fredericksburg and Exit at Rt. 3 West to Culpepper. Stay on Rt. 3 until you get to Wilderness (about 15 miles) and turn left onto Rt. 20 South to Orange VA. Stay on Rt. 20 through Orange and continue as above.

From Richmond:

Take I-64 West to Exit 124, Rt. 250, West -Shadwell/Charlottesville. About 1 mile turn right onto Rt. 20, Stony Point Rd. Go about 6 miles and turn right onto Woodcreek Drive to the fifth house on the right (Yellow).

From the West:

Take I-64 EAST to Charlottesville. Exit at Exit 118, US 29 Bypass. US 29 and Rt. 250 merge then separate. Stay on Rt. 250 Bypass. On East side of City, you will come to Rt. 20. Cross over the Rivanna Bridge and take next left onto Rt. 20 to Orange/Barboursville, VA. Proceed about 6 miles to Woodcreek Drive and turn right. Continue as above.
