# **Updates From the Field**

#### From Ellen Ripper

The field trial community finished the spring season with three straight trials at the Wyoming Valley B.C. in Hunlock Creek, PA, our hosts for three different basset clubs: Valley Forge, Patroon and Lenape.

Capital and Pilgrim BHC held pack trials at Towanda BC.

Susquehanna and Berkshire Valley BH Clubs all held trials from Central Jersey BC Flemington, NJ to Swatara BC in Elizabethtown, PA.

Many good running dogs finished their championships and moved up to the Champion class. We had large entries and many good runs by these experienced hounds.

A Hunting Performance Test is scheduled for June in RI. After this event, trialing will shut down until fall. This is a sanctioned BHCA event for different scent hound breeds, including: bassets, PBGV, GBGV, dachshunds, beagles, and harriers. Like field trialing, there are different categories where the dogs will be evaluated.

The three classes are Solo, Brace and 2 Coupled Pack. Each one allows the competitor to run their dogs for up to half an hour.

The Fireside hunters, FC Fireball, FC Bourbon and their son Snowball placed at many of the field trials. Both Champions are working on their Grand Championship and Snowball on his FC.
