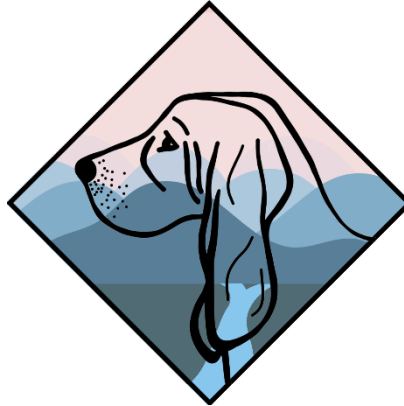

An event committee hearing will be held for individuals reported by any of these hotels/motels for not respecting motel property. Do not let your dogs destroy or foul rooms. No grooming or bathing of dogs in rooms. Clean up after your dog outside and limit barking and other noise. Hotel quiet time: 10:00 PM to 6:00 AM. Please respect others.

Information about the Trial Site; Directions

Trial Site - These trials will be held at the Stafford Regional Handbell Society Rehearsal and Performance center located at 106 Banks Ford Parkway, Fredericksburg VA 22406. These are one ring trials.

Ring site is approximately 40 feet by 50 feet in size. The building is heated and air conditioned, and the floor surface is carpeted. **There is space available for indoor crating, but you must place a tarp or mat under your crates.**

Please clean up after your dogs and yourselves.

Food will not be available on site. Bring your own snacks and drinks. There is a selection of restaurants within a short distance from the trial site.

Directions from I-95. Take exit 133 US 17 N to Warrenton. Remain on Warrenton Road for approximately 2 miles. Turn Left on Banks Ford Parkway (after the Celebrate Virginia Shopping Center and before Geico.) Building is on right approximately three tenths of a mile past Geico and immediately after Hartwood Animal Hospital. Use main entrance. Parking is free

From Warrenton or points North and West: Take US 17 Business South toward Falmouth. Immediately past Geico, turn right on Banks Ford Parkway. Building is ahead about 3/10 of a mile on the right hand side immediately after Hartwood Animal Hospital. Use main entrance. Parking is free

Transfers

Transfers (including transfers between an “A” and “B” class at the same level) must be made in writing and must be received by the Trial Secretary in accordance with the applicable AKC Regulations. For transfers made prior to October 31, 2024, emails will be accepted as long as the email includes the dog’s call name and AKC registration number, owner’s name, original class entered, and new class requested. For transfers made at or on the days of the shows, the request must be made on AKC approved forms which are available online at the AKC’s website, <https://www.akc.org/downloadable-forms/> , or from the Trial Secretary.

Exhibitors should consult the judging program and final confirmation for more specific information on judging and the running of the trials. The judge may take breaks at his discretion, and any such breaks may impact the running and completion of the trials. Handlers should check in at least 15 minutes before their class is to be judged. The judge will not wait for any dog holding up a class. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.

PBHC assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property. Children are the responsibility of their parents and must be under control at all times.

No dogs under the age of six months may be entered in the trial, and no dogs will be allowed in the trial area except those entered in the trial. No dogs will be allowed in the building prior to opening. No dogs will be allowed in the rings unless they are being judged.

At the trial site, all dogs must be on leash or confined to their crates except when being judged. PBHC considers the trial site to be (i) the building where the trials are being held, (ii) the area immediately surrounding the building.

Exhibitors, handlers and others attending the trial waive any claim for damages against PBHC or its members or agents in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation because of improper ventilation.

Exhibitors and handlers are responsible for clean conditions in and around their vehicles and the trial site, and must clean up after their dogs. Exhibitors who are seen not cleaning up after their dogs will be excused from the trial.
