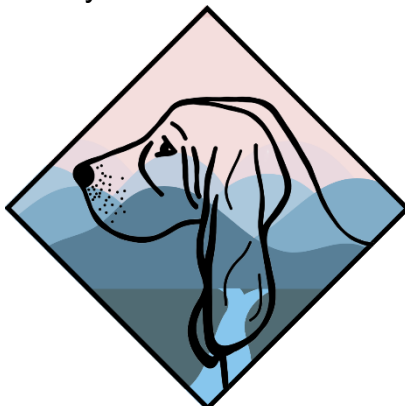

Unless entry limits are reached on an earlier date, entries close on Wednesday, October 23, 2024 (at 11:59 am EDT) for the Obedience trial and Saturday November 2, 2024 (at 11:59 EDT) for the Rally trial, after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

### **Information about the Trial Site; Directions**

---

**Trial Site** - These trials will be held at the Stafford Regional Handbell Society Rehearsal and Performance center located at 106 Banks Ford Parkway, Fredericksburg VA 22406. These are one ring trials.

Ring site is approximately 40 feet by 50 feet in size. The building is heated and air conditioned, and the floor surface is carpeted. **There is space available for indoor crating, but you must place a tarp or mat under your crates.**

Please clean up after your dogs and yourselves.

**Food will not be available on site.** Bring your own snacks and drinks. There is a selection of restaurants within a short distance from the trial site.

**Directions from I-95.** Take exit 133 US 17 N to Warrenton. Remain on Warrenton Road for approximately 2 miles. Turn Left on Banks Ford Parkway (after the Celebrate Virginia Shopping Center and before Geico.) Building is on right approximately three tenths of a mile past Geico and immediately after Hartwood Animal Hospital. Use main entrance. Parking is free

**From Warrenton or points North and West:** Take US 17 Business South toward Falmouth. Immediately past Geico, turn right on Banks Ford Parkway. Building is ahead about 3/10 of a mile on the right hand side immediately after Hartwood Animal Hospital. Use main entrance. Parking is free

## Transfers

---

Transfers (including transfers between an “A” and “B” class at the same level) must be made in writing and must be received by the Trial Secretary in accordance with the applicable AKC Regulations. For transfers made prior to October 31, 2024, emails will be accepted as long as the email includes the dog’s call name and AKC registration number, owner’s name, original class entered, and new class requested. For transfers made at or on the days of the shows, the request must be made on AKC approved forms which are available online at the AKC’s website, <https://www.akc.org/downloadable-forms/> , or from the Trial Secretary.

## Notice to Exhibitors

---

**The Trial** will be held indoors (see information about the Trial Site elsewhere in this premium). Please note there are separate entry forms for the obedience trials and the rally trials.

**Entries each day will be limited to the number that can be judged in eight hours of judging time, and entries will close automatically when this limit is reached, even if it is before the published closing date for entries. A wait list will be maintained to fill openings created by the withdrawal of entries prior to the published closing date. Exhibitors whose entries do not move off of the wait list prior to the published closing date will have their checks destroyed.**

### Entry Fees are as follows:

First Entry of a dog .....	\$33
Second Entry of the same dog in the same trial .....	\$33

Entry fees include all applicable AKC event service and recording fees. Please make checks payable to “Potomac Basset Hound Club” and be careful when calculating entry fees. Each trial is separate. Entering the same dog in multiple trials on the same day requires a “First Entry” fee for each event. **Please contact the Trial Secretary if you have questions. Overpayments of less than \$5 will not be refunded.**

**Please pre-pay if you wish to purchase a catalog.** The cost of a pre-paid catalog is \$5, and you should check the box on the entry form and include payment of \$5 per catalog with your entry fees. A limited number of additional catalogs will be available at the trial at a cost of \$8 each.

**Opening and closing date for entries:** Entries open at 8:00 AM on Wednesday, August 15, 2024 and, unless entry limits are reached on an earlier date, close at 11:59 AM, Wednesday, October 23, 2024 for the Obedience Trial and Saturday November 2, 2024 for the Rally Trial.

**Please remember** to include the dog’s jump height for **ALL** classes in the Obedience Trials and the Rally Trials. The running order for these classes will be as follows:

Obedience Tall-to-small starting with dogs jumping 36 inches

Rally - Tall-to-small starting with dogs jumping 16 inches

**Entries will not be accepted without fees.** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by action of the Show Committee, except for bitches who come into season after the closing date, in which case PBHC will refund the applicable entry fee less \$3 per run, per

day. Exhibitors must submit a refund request to the Trial Secretary no later than thirty (30) minutes prior to the start of the first class of the first day of the trial in which the dog is entered to be eligible for a refund.

**A preliminary confirmation** of the receipt of an entry will be made as soon as practicable if an exhibitor legibly includes an active e-mail address on the completed entry form. A final confirmation of an entry and the judging schedule will be forwarded to each exhibitor after the closing date. If you have not received a final confirmation within four days of the trial date, please contact the Trial Secretary. The final confirmation and judging schedule will be sent by e-mail unless the exhibitor does not have an active e-mail account or unless the exhibitor specifically requests otherwise, in which case the final confirmation and judging schedule will be sent by US mail.

**Entries must be submitted on an official American Kennel Club form**, signed by the owner or authorized agent. Entries not on an official AKC entry form and photocopies of entry forms without the required AKC agreement and rules will not be accepted. Unsigned entry forms, as well as entry forms that are delivered by e-mail or facsimile transmission, will not be accepted.

**No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Checks with conditions or limits (including post-dating) will not be accepted. Returned checks do not constitute a valid entry fee. The Trial Secretary will add a collection fee of \$25 to the amount of each returned check. Entries cannot be accepted, cancelled, altered, or substituted after entries have closed.

**Owners are responsible** for the proper completion of entry forms, and no entry fee will be refunded in the event of an error or cancellation of an entry after the closing date.

**If, because** of riot, wars, civil disturbances, extreme weather conditions, national emergencies, health emergencies, or other acts beyond the control of PBHC, it is not possible, in the sole judgment of the Show Committee, to open or complete the trial, no refund of entry fees will be made. Extreme weather conditions, such as snow storms, ice, hurricanes, lightning, extreme heat, extreme cold, heavy rains, or other conditions that may affect the health and safety of the dogs, exhibitors and spectators, including the condition of the facilities or grounds and/or ingress and egress from the grounds, may be considered by the Show Committee in making any determination to open or complete the trial.

**PBHC reserves the right** to decline any entries or remove a dog from an obedience or rally trial for cause.

**PBHC will allow** the Trial Secretary to enter dogs owned or co-owned by the secretary in an obedience or rally trial and will allow the secretary to handle dogs in an obedience or rally trial. In addition, dogs owned or co-owned by any member of the trial secretary’s household may be entered in an obedience or rally trial.

**The trial site** will be open from 7:30 AM on Saturday and will remain open each day until one hour after the conclusion of the judging.

**Judging for the obedience and rally trials** will start at the following times:

**Exhibitors should consult** the judging program and final confirmation for more specific information on judging and the running of the trials. The judge may take breaks at his discretion, and any such breaks may impact the running and completion of the trials. Handlers should check in at least 15 minutes before their class is to be judged. The judge will not wait for any dog holding up a class. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.

**PBHC assumes no responsibility** for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property. Children are the responsibility of their parents and must be under control at all times.

**No dogs** under the age of six months may be entered in the trial, and no dogs will be allowed in the trial area except those entered in the trial. No dogs will be allowed in the building prior to opening. No dogs will be allowed in the rings unless they are being judged.

**At the trial site, all dogs must be on leash** or confined to their crates except when being judged. PBHC considers the trial site to be (i) the building where the trials are being held, (ii) the area immediately surrounding the building.

**Exhibitors, handlers and others attending the trial** waive any claim for damages against PBHC or its members or agents in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation because of improper ventilation.

**Exhibitors and handlers** are responsible for clean conditions in and around their vehicles and the trial site, and must clean up after their dogs. Exhibitors who are seen not cleaning up after their dogs will be excused from the trial.

1. (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., A or B division.
3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC (For complete rules, refer to Chapter 11, Section 3.)
4. Dogs listed in the AKC Canine Partners Program may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All-American Dog and must include their AKC Number on their entry form and check the AKC No. Box. Sire and Dam information shall remain blank for mixed breed dogs.
